### 6. PUBLIC HEARING ITEMS

Any member of the public may address the Commission with respect to a scheduled public hearing item. Comments should be limited to no more than five minutes unless additional time is permitted by the Chair.

a) Municipal Service Review and Sphere of Influence Update for the City of Calistoga (15 Minutes) Part 1 (Staff Report and Attachment One) / Part 2 (Attachments Two through Six)

The Commission will review a final Municipal Service Review and Sphere of Influence Update for the City of Calistoga. The final report examines the availability and adequacy of municipal services provided by Calistoga relative to the Commission's mandates to facilitate orderly growth and development. The Commission will consider adopting a resolution confirming the determinative statements in the report and affirming the existing sphere of influence with no changes. The Municipal Service Review and recommended sphere affirmation are exempt from further review under the California Environmental Quality Act pursuant to California Code of Regulations Sections 15306 and 15061(b)(3), respectively. The recommended action is to continue the public hearing to the Commission's December 5, 2016 meeting.

#### a) <u>Draft Municipal Service Review and Sphere of Influence Update for the Napa River Reclamation</u> <u>District No. 2109</u> (20 Minutes)

The Commission will review a draft Municipal Service Review and Sphere of Influence Update for the Napa River Reclamation District No. 2109. The draft report examines the availability and adequacy of municipal services provided by the District relative to the Commission's mandates to facilitate orderly growth and development. The draft report also contemplates potential changes to the District's sphere of influence. The Commission is invited to discuss the draft report and provide feedback to staff in anticipation of receiving a final Municipal Service Review and Sphere of Influence Update for formal action as part of a public hearing at a future meeting. No action will be taken by the Commission as part of this item.

## 8. ACTION ITEMS

### a) **Proposed Silverado Trail No. 2 Annexation to the Napa Sanitation District (5 Minutes)**

The Commission will consider a landowner petition to annex approximately 0.9 acres of unincorporated territory to the Napa Sanitation District (NSD). The affected territory is located at 1944 Silverado Trail and within NSD's sphere of influence. Staff has modified the proposal to include the adjacent portion of public right-of-way. The purpose of the proposed annexation is to allow the existing single-family residence and detached second unit to connect to NSD's public sewer infrastructure. The modified proposal is exempt from CEQA under Public Resources Code Section 15319(a). The recommended action is for the Commission to adopt a resolution approving the proposal as modified with standard terms and conditions.

#### b) Work Program Update (5 Minutes)

The Commission will receive a report that summarizes recent progress on the planning and regulatory activities established in the 2016-2017 Work Program. The Commission is invited to discuss the report and consider directing staff to make any changes to the Work Program as desired. Staff recommends the Request for Proposals (RFP) Subcommittee be reconvened to help in the preparation of the next RFP and in the selection of the next consultant, as well as to assist in addressing issues regarding the schedule of studies currently being prepared by the existing consultant.

An interested party includes an applicant and any person with a financial interest actively supporting or opposing a proposal.
