SUBJECT: Work Program Progress Report

RECOMMENDATION

It is recommended the Commission discuss the 2017-2018 Work Program progress report and draft schedule of new municipal service reviews and sphere of influence updates. The Commission may provide direction to staff with respect to any desired changes.

BACKGROUND

Local policy directs the Commission to annually adopt a Work Program for purposes of providing a comprehensive overview of agency activities over the course of the fiscal year. The Work Program also serves as a management tool to measure the agency's performance and is intended to provide the Commission with opportunities to identify and address changes in priorities. The 2017-2018 Work Program was formally adopted by the Commission on June 5, 2017.

SUMMARY

The Commission will receive a progress report on the planning and regulatory activities established in the 2017-2018 Work Program. The majority of planning and regulatory activities identified in the Work Program involve municipal service reviews (MSRs) and sphere of influence (SOI) updates. Other planning and regulatory activities include boundary change proposals and outside service requests. A Work Program progress chart is included as Attachment One. The Commission will also receive a draft schedule of new MSRs and SOI updates recommended by staff to be completed through calendar year 2020 (Attachment Two). The Commission is invited to provide direction to staff with respect to desired changes to the Work Program or the draft schedule of new MSRs and SOI updates. A brief summary of each item follows.

In Progress Work Program Activities

The following planning and regulatory activities in the 2017-2018 Work Program are currently in progress:

- <u>City of St. Helena MSR and SOI Update</u>
 A comprehensive draft report is included on today's agenda as discussion item 7a.
- Congress Valley Water District MSR and SOI Update
 A final report is included on today's agenda as public hearing item 6a.
- County Service Area No. 4 MSR and SOI Update
 A checklist format report will be presented for formal action at the Commission's December 4, 2017 meeting as part of a noticed public hearing.
- South County Region MSR and SOI Updates
 The South County Region includes the City of American Canyon, American
 Canyon Fire Protection District, and County Service Area No. 3. A
 comprehensive report is expected to be completed by April 2018 with a consultant
 (E Mulberg & Associates) as the lead. A draft report is expected to be presented at
 the Commission's December 4, 2017 meeting. The consultant will provide a
 verbal update at today's meeting as part of discussion item 7b.

Study Schedule Through 2020

A draft schedule of new MSRs and SOI updates ("study schedule") to be completed through calendar year 2020 is included as Attachment Two. It is important to note the draft study schedule includes comprehensive countywide MSRs for public water and sewer service providers. Staff recommends these countywide water and sewer MSRs be prepared by consultants and with a focus on identifying opportunities for shared services and resources. The draft study schedule includes target completion dates of December 2018 and June 2019 for the countywide water and sewer MSRs, respectively.

Potential outcomes of these MSRs would be new contractual service relationships and/or governmental reorganizations (e.g. consolidations or mergers) involving local agencies. Additionally, these MSRs would inform the state mandated SOI updates for all local agencies that provide one or both of these municipal services.

These countywide water and sewer MSRs would require the Commission to release two separate Requests for Proposals (RFPs) to solicit proposals from qualified private consulting firms. If the Commission is agreeable, staff will return with draft RFPs as early as the February 5, 2018 meeting. Once approved by the Commission, the RFPs would be released for a period of approximately 45 days before interviews with responding consultants would be scheduled.
