RECOMMENDATION

It is recommended the Commission discuss the 2017-2018 Work Program progress report and consider providing direction to staff with respect to any desired changes.

BACKGROUND

Local policy directs the Commission to annually adopt a Work Program for purposes of providing a comprehensive overview of agency activities over the course of the fiscal year. The Work Program also serves as a management tool to measure the agency's performance and is intended to provide the Commission with opportunities to identify and address changes in priorities. The 2017-2018 Work Program was formally adopted by the Commission on June 5, 2017 and is included as Attachment One.

SUMMARY

Staff will summarize recent progress on the planning and regulatory activities established in the 2017-2018 Work Program. The majority of planning and regulatory activities identified in the Work Program involve municipal service reviews (MSRs) and sphere of influence (SOI) updates. Other planning and regulatory activities include boundary change proposals and outside service requests.

The Commission is invited to discuss the proposed Work Program and consider providing direction to staff with any desired changes. Possible changes include – but are not limited to – priority levels, estimated start and completion dates, project leads, and format (comprehensive, abbreviated, or checklist) for MSRs and SOI updates. Additionally, the potential adoption of a strategic plan in the foreseeable future may result in additional changes to the Work Program.

A Work Program progress chart is included as Attachment Two. One significant change has been made since the Work Program was adopted on June 5th. The change involves the addition of an island annexation program. Additional changes are limited to the addition of two annual administrative activities that were requested by Commissioners as part of the May 1, 2017 strategic planning workshop. All changes are highlighted in the Work Program progress chart. A brief summary of planning and regulatory activities included in the Work Program follows.

In Progress Activities

The following activities are currently in progress:

- City of St. Helena MSR and SOI Update
 - A consultant prepared an administrative draft report, which has been circulated to St. Helena staff and County staff for technical review. The consultant contract expired on June 30, 2017 and the Executive Officer has taken the lead. St. Helena recently hired a new City Manager who will need a sufficient amount of time to conduct a thorough review of the administrative draft report. A comprehensive public draft report is expected to be presented for discussion at the Commission's October 2nd meeting.
- <u>Congress Valley Water District MSR and SOI Update</u> A final report is included on today's agenda as public hearing item 6a.
- <u>County Service Area No. 4 MSR and SOI Update</u> Staff has begun collecting information on County Service Area No. 4. A checklist format report will be presented for formal action no later than December 2017.
- South County Region MSR and SOI Updates

The South County Region includes the City of American Canyon, American Canyon Fire Protection District, and County Service Area No. 3. A comprehensive report is expected to be completed by April 2018 with a consultant (E Mulberg & Associates) as the lead. The consultant has agreed to attend the Commission's October 2nd meeting and provide a verbal update.

New Activities

The following new activity is included in the current version of the Work Program:

• Island Annexation Program

At its June 5th meeting, the Commission discussed proactive annexation of unincorporated islands. Toward this end, item 7a on today's agenda provides a summary of the costs and process associated with island annexations. The island annexation program is expected to require significant staff resources and participation from the City of Napa as well as the County of Napa. An estimated timeline for the Commission to take formal action to approve the annexation of some or all islands is approximately 12 to 24 months. The timeline and outcomes are partially dependent on the level of commitment the Commission receives from the City of Napa with respect to conducting outreach and prioritizing this activity.

Sphere of Influence Update Mandate

California Government Code (G.C.) Section 56425(g) states: "On or before January 1, 2008, and every five years thereafter, the commission shall, as necessary, review and update each sphere of influence." Toward this end, at its June 5th meeting, the Commission expressed interest in receiving information specific to the most recently completed SOI update for each local agency under LAFCO's purview in Napa County. A chart that shows all 23 local agencies with hyperlinks to their most recently completed SOI updates is included as Attachment Three. It is important to note that G.C. Section 56106 states any provisions governing timing of the Commission's actions shall be deemed directory rather than mandatory with limited exceptions. Therefore, the Commission may deviate from the five-year cycle for SOI updates described in G.C. Section 56425(g).
