a) Contract Extension and Budget Amendment for Recruitment Services – Executive Officer Position

The proposed amendment would extend the period of the contract to July 31, 2015 and allow a maximum expenditure amount not to exceed \$10,000. The Commission will also consider reallocating appropriations from the Fund Balance/Undesignated Reserves (Account No. 33100) to the Consulting Services Account (Account No. 52310) to pay contract expenses.

b) Retention of Legal Counsel

The Commission will consider the retention of the firm Miller & Owen as the Commission's legal counsel and the approval of a Professional Services Agreement for those services.

An interested party includes an applicant and any person with a financial interest actively supporting or opposing a proposal.
