- 4. COMMISSION ACTION ITEMS
 - a) Impartial Analysis on the Napa County Regional Park and Open Space District
 The Commission will consider the approval of an impartial analysis regarding the proposed
 formation of the Napa County Regional Park and Open Space District. The formation of the
 proposed district has been initiated by resolutions of the County of Napa Board of
 Supervisors. (California Government Code §57144 and Public Resources Code §5517.1)
 PRESENTATION PROVIDED BY STAFF. THE COMMISSION DISCUSSED AND
 APPROVED THE IMPARTIAL ANALYSIS REGARDING THE PROPOSED
 FORMATION OF THE NAPA COUNTY REGIONAL PARK AND OPEN SPACE
 DISTRICT WITH TWO MODIFICATIONS:
 - 1) INSERT THE WORD "SEPARATE" INTO THE THIRD SENTENCE OF THE THIRD PARAGRAPH. NEW SENTENCE TO READ: All assessments and general obligation bonds would require separate voter approval.
 - 2) CHANGE TEXT FROM UPPER TO LOWER CASE IN THE LAST SENTENCE OF THE THIRD PARAGRAPH. NEW SENTENCE TO READ: This measure does not authorize the levy of any assessments or bonds.

ADDITIONALLY, THE COMMISSION DIRECTED STAFF TO TRANSMIT A CERTIFIED COPY OF THE APPROVED IMPARTIAL ANALYSIS TO THE NAPA COUNTY REGISTRAR OF VOTERS.
