**SUBJECT:** Regular Commission Meeting Calendar: Policy Review and Adoption

of Calendar for the First-Half of 2007 (Action)

The Commission will review its policy regarding the calendaring of its regular meetings on the first Monday of even-numbered months. The Commission will consider whether it wishes to keep or amend this policy prior to adopting a calendar for the first-half of the 2007 calendar year.

The Commission's Regular Commission Meeting Calendar policy calls for the adoption of a calendar every six months (policy attached). This policy states that the regular meetings of the Commission shall fall on the first Monday of even-numbered months at 4:00pm. For the first six months of 2007, the first Monday of each even-numbered month falls on February 5, April 2, and June 4.

The need to calendar regular meetings for the first-half of 2007 provides an opportunity for the Commission to consider whether it wishes to make any amendments to its current policy. Staff is aware that in the past some Commissioners have expressed interest in moving to a monthly meeting schedule. With this in mind, and in anticipation of this meeting, staff conducted an informal survey to determine whether there was interest among current Commissioners in meeting monthly. Although no majority preference was expressed, the survey did confirm that there is interest among current Commissioners in meeting monthly.

In reviewing this potential change, staff recognizes that a key advantage to moving to a monthly meeting schedule is that the meetings, which now regularly cover a range of actions and discussions, could become more focused on specific issues. Staff anticipates that the Commission will remain busy over the next calendar year as it works to complete six service reviews and eighteen sphere updates prior to the Legislature-imposed January Monthly meetings would help bring these studies before the 1, 2008 deadline. Commission in an orderly manner. However, staff also recognizes that monthly meetings would result in additional time demands on Commissioners, especially for members residing outside the City of Napa. Monthly meetings from time to time would also produce light agendas during transitions in workload. This may produce a need for the Commission to cancel a scheduled meeting due to a lack of business.

Staff recommends that the Commission discuss whether it wishes to amend its *Regular Commission Meeting Calendar* policy to begin meeting monthly. Once the Commission has determined whether to keep or amend this policy, it should take one of the following actions:

**Option A:** If the Commission wishes to keep its policy to meet on evennumbered months, it should approve regular meetings for the firsthalf of 2007 for February 5, April 2, and June 4.

**Option B:** If the Commission wishes to amend its policy to meet each month, it should 1) approve the attached draft amendment to its *Regular Commission Meeting Calendar* policy along with any other desired changes and 2) approve regular meetings for the first-half of 2007 for February 5, March 7, April 2, May 7, and June 4.\*

\* The first Monday of January falls on New Year's Day. Rather than reschedule for a later date, staff recommends that the Commission not calendar a January meeting.
