

Napa Pipe History

 Formerly owned by Basalt Rock Company and used to make ships for the American war effort in World War II and had an aerial tram that brought rocks from a nearby quarry to the site




Napa Pipe History

• Later owned by Kaiser Steel Corporation and used to manufacture pipes, oil rig platforms, parts for the Dumbarton Bridge, and parts for the Transamerica Pyramid in San Francisco



Napa Pipe Project

- Up to 945 residential dwelling units
- 34 acres of public parks, open space, wetlands, and trails
- 154,000-square foot Costco retail center and gas station
- 150 senior housing units
- 150 unit hotel



Napa Pipe Project

• 15,600 square feet of various community facilities

• 40,000 square feet of retail and restaurant space

• 100,000 square feet of office space

• 75,000 square feet of industrial, research and development or warehousing space



Napa Pipe Project

• City recently amended its General Plan to designate the eastern parcel as Mixed Use and the western parcel as Light Industrial and add site to RUL




Napa Pipe Project

• County recently amended its General Plan to designate both parcels as Napa Pipe Mixed Use



Napa Pipe Project

• City and County each recently assigned a mix of matching zoning/prezoning designations for the entire site to ensure appropriate project planning



Napa Pipe Project


• The City and County each adopted resolutions pertaining to design guidelines, the development plan, and the development agreement for the Napa Pipe project



Napa Pipe Project


• Napa Sanitation District wastewater service (project is already within NSD's boundary)

• City of Napa for all other municipal services



Napa Pipe Project

 Existing City/County agreements include the provision of municipal services, regional housing needs allocations, tax sharing, and an amendment to the City's sphere of influence




Napa Pipe Project

• Water service to Napa Pipe is subject to a separate agreement executed between the City and the landowner





- 3. Outside Service Agreement




Sphere of Influence Amendment

- 136 acres (18 acres already in City SOI)
- Commission in
 2014 signaled
 eventual SOI
 expansion for Napa
 Pipe (City of Napa
 SOI Update)



Sphere of Influence Amendment


• As part of the 2014 SOI update, the Commission chose to defer action until the City's RUL was amended and service commitments were officially in place



Annexation


• 111 acres (nonresidential portions)

• Central County Region MSR paired with subsequent analysis indicates the City has adequate capacities and controls to serve




Annexation

• Modification: concurrent detachment from CSA No. 4 (Napa Pipe has no connection to vineyards and the need to fund farmworker housing)



Outside Service Agreement

- 43 acres (residential portion)
- OSA in anticipation of future annexation (City/County agreements require annexation by 12/31/2022)



- County certified a Final Environmental Impact Report on January 14, 2013
- City approved an Initial Study/Addendum on July 21, 2015
- Commission as responsible agency will consider making findings that no additional environmental analysis is required (Attachment One)

 The Commission will consider certifying that it has reviewed and considered the environmental effects and information in the County's FEIR and City's Addendum. The Commission will consider a determination that the County's Certified Napa Pipe EIR and the City's Initial Study/Addendum were completed in compliance with CEQA and are adequate for its use in approving the Napa Pipe Proposal 20

 The Commission will consider approving and adopting the County's Findings, Statement of Overriding Considerations, and a Mitigation Monitoring and Reporting Program

 The Commission will consider finding that there have been no significant changes in the project or in the environment since the preparation of the Certified Napa Pipe EIR and the Initial Study/Addendum

 Commission will consider adopting the applicable mitigation measures contained within the Initial Study/Addendum and the County's "Mitigation Monitoring and Reporting Program" (The City and County shall be responsible for implementing all mitigation identified in the MMRP and for overall administration of the MMRP)

Alternatives for Commission Consideration

(Must first open Public Hearing and invite public testimony):

- Close the Public Hearing and adopt all three resolutions approving (1) CEQA findings,
 (2) SOI & OSA, and (3) Annexation
- 2) Continue the Public Hearing to a future regular meeting
- 3) Close the Public Hearing and disapprove the proposal 24

Recommendation

Take the actions consistent with Alternative One to adopt the following three Resolutions:

- 1. CEQA findings (Attachment One)
- 2. Approve SOI amendment and OSA involving the City (Attachment Two)
- Approve annexation to the City and concurrent detachment from CSA No. 4 (Supplemental Attachment)
