SUBJECT: Executive Officer Report

SUMMARY

This item includes a summary of the Executive Officer's recent activities as well as other miscellaneous items pertaining to LAFCO. This item is for information purposes only. No formal action will be taken by the Commission as part of this item.

New Legal Counsel Primary Contact

Following the departure of Jennifer Gore from Renne Sloan Holtzman Sakai (RSHS), the Commission's new primary legal counsel contact is Madeline Miller. Ms. Miller has been directly involved in RSHS' representation of Sacramento LAFCO and San Francisco LAFCO for 13 years and has extensive experience processing sphere of influence amendments, annexations, and municipal service reviews. Ms. Miller's resume is included as Attachment One.

City Member Vacancy

One of the Commission's City Member seats was vacated on November 8 with the departure of Juliana Inman, resulting in an unexpired term for the City Member seat. The LAFCO term for this seat expires in May 2019 as reflected in Agenda Item 5i.

Pursuant to the City Selection Committee's adopted policy, the City of Napa retains the LAFCO seat and nominates a Councilmember to serve the remainder of the unexpired term. The City Selection Committee then considers an official appointment at its next meeting. Toward this end, the City of Napa has nominated Councilmember Scott Sedgley to serve the remainder of the unexpired term. The City Selection Committee's next meeting is scheduled for January 9, 2018, at which time the appointment is expected to be formally made. It is anticipated the newly appointed Commissioner will be sworn in at the Commission's February 5, 2018 meeting.

CALAFCO Conference

CALAFCO's 2017 Annual Conference was held from October 25, 2017 through October 27, 2017 at the Bahia Resort in San Diego. The Commission was represented at the Conference by the Executive Officer, Secretary Mabry, Chair Wagenknecht, and Commissioner Mohler. Additionally, Napa City Councilmember (and expected new Commissioner) Scott Sedgley attended the Conference.

Most notably, Commissioner Mohler was elected to the CALAFCO Board of Directors and will serve a two-year term as a city member representing the Coastal Region. Commissioner Mohler's first CALAFCO Board meeting was on October 27, 2017 and the next CALAFCO Board meeting is scheduled for December 8, 2017 in Sacramento. A letter of appreciation from CALAFCO that congratulates Commissioner Mohler for her election to the CALAFCO Board of Directors is included as Attachment Two.

The Executive Officer participated as a member of the Conference Planning Committee and assisted in the development of general and breakout sessions. The Executive Officer also coordinated and moderated a session titled "Commission Decisions: the Great Balancing Act" with a speaker panel that included three CALAFCO Board members – Michael McGill of Contra Costa LAFCO, Josh Susman of Nevada LAFCO, and Shiva Frentzen of El Dorado LAFCO – along with Chair Derek McGregor of Orange LAFCO.

Other notable topics that were covered at the Conference included transparency, communicating with the public, local agency fiscal health, Commissioners and Executive Officers expectations, unincorporated islands, ethics, and new legislation.

REPRESENTATIVE CASES

Cequel III Communications I, LLC v. Nevada County LAFCo (2007) 149 Cal.App.4th 310

Nancy Miller and Madeline Miller successfully represented the Truckee Donner Public Utility District in this action challenging a decision by the Nevada County Local Agency Formation Commission. The Plaintiff in the action is a cable company seeking to prevent the District from providing broadband and other services. The Superior Court ruled in favor of the District and Nevada LAFCo. The Plaintiff appealed the decision and after briefing and oral argument, the decision was upheld in favor of the District and Nevada LAFCo.

Pacific Gas and Electric Company v. Sacramento Municipal Utility District; Sacramento LAFCo (2007)

Sacramento County Superior Court, Case No. 05GS01582

Sacramento LAFCo has retained the firm to act as General Counsel since 1993. We have processed numerous annexation requests for cities and special districts including large service areas such as Sacramento Municipal Utilities District's (SMUD) proposed annexation of parts of Yolo County, which was the subject of this case. The firm successfully defeated PG&E's challenge to SMUD's annexation.

ECOS v. City of Sacramento Local Agency Formation Commission Sacramento Superior Court (2013)

Superior Court Case No. 34-2008-00004668

Nancy Miller and Madeline Miller, with assistance from Jennifer Gore, successfully defended the LAFCo and the City against CEQA claims from environmentalists in connection with LAFCo's approval of the annexation of the Greenbriar project area by the City. The Petitioner appealed and the firm successfully settled that appeal, which allowed the development process to move forward.
