## b) Proposed Budget for Fiscal Year 2024-25 and Draft Work Program

The Commission considered adopting a resolution to approve a proposed budget for the 2024-25 fiscal year. Proposed operating expenses and revenues each total \$913,362. The recommended actions are for the Commission to do the following: (1) adopt the proposed budget by resolution; (2) direct staff to circulate the proposed budget for public review and comment; and (3) direct the Budget Committee to return with recommendations for a final budget for adoption at a noticed public hearing on June 3, 2024. The Commission also considered a draft work program for fiscal year 2024-25.

Substantial discussion took place with numerous requests for budget revisions and additional information to be provided prior to adoption. With a motion by Commissioner Mohler and a second by Commissioner Leary to continue this Agenda item to April 25, 2024 at 2:00 PM at Yountville Town Hall Council Chambers as a Special Meeting, the motion carried with the following vote:
