NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN BY THE LOCAL AGENCY FORMATION COMMISSION (LAFCO) OF NAPA COUNTY that on **Monday, October 5, 2026 at 2:00 PM** in the Chambers of the Board of Supervisors, Third Floor, County Administration Building, 1195 Third Street, Napa, California, 94559, LAFCO will conduct a public hearing to consider the following:

SPHERE OF INFLUENCE AMENDMENT REQUEST INVOLVING THE CITY OF AMERICAN CANYON AND THE AMERICAN CANYON FIRE PROTECTION DISTRICT (057-090-065 and 057-090-089)

Pursuant to California Government Code Section 56425, LAFCO of Napa County will consider a landowner request to amend the City of American Canyon's sphere of influence and the American Canyon Fire Protection District's sphere of influence to include approximately 284.6 acres of unincorporated territory that comprises two parcels identified by the County of Napa Assessor's Office as 057-090-065 and 057-090-89 (the "Hess-Laird SOI Amendment Application").

CEQA DETERMINATION: LAFCO of Napa County will consider adopting a finding that the Hess-Laird SOI Amendment Application is not subject to the California Environmental Quality Act ("CEQA") or is otherwise exempt from review under CEQA.

ALL INTERESTED PERSONS ARE INVITED TO ATTEND THE ABOVE SPECIFIED HEARING AND TO BE HEARD REGARDING THE LISTED ACTIONS.

LAFCO will consider oral and written testimony by any interested person or affected agency.

If you challenge the action of LAFCO on any of the above stated items in court, you may be limited to only those issues raised at the public hearing described in this notice, or in written correspondence delivered to the Local Agency Formation Commission of Napa County prior to the close of the public hearing.
