NOTICE IS HEREBY GIVEN BY THE LOCAL AGENCY FORMATION COMMISSION (LAFCO) OF NAPA COUNTY that a regular meeting will be held on **Monday, June 1, 2026 at 2:00 PM** in the Chambers of the Board of Supervisors, Third Floor, County Administration Building, 1195 Third Street, Napa, California, 94559, LAFCO will conduct public hearings to consider the following four items:

**ADOPTION OF A FINAL BUDGET FOR FISCAL YEAR 2026-27**

Pursuant to California Government Code section 56381, LAFCO will review and adopt a final budget for the 2026-27 fiscal year.

**SPHERE OF INFLUENCE AMENDMENT AND ANNEXATION INVOLVING THE NAPA SANITATION DISTRICT AND 1089 EL CENTRO AVENUE**

Pursuant to California Government Code sections 56425 and 56375, LAFCO will consider a sphere of influence amendment involving the Napa Sanitation District and one entire unincorporated parcel located at 1089 El Centro Avenue and identified by the County of Napa Assessor's Office as 038-110-050. Concurrent annexation of the parcel to the Napa Sanitation District will also be considered as part of this item.

**PAOLI LOOP/WATSON LANE REORGANIZATION INVOLVING ANNEXATION TO THE CITY OF AMERICAN CANYON & DETACHMENT FROM COUNTY SERVICE AREA NO. 4**

Pursuant to California Government Code section 56375, LAFCO will consider a proposal from the City of American Canyon to annex approximately 86.9 acres of unincorporated territory to the City and concurrently detach the affected territory from County Service Area No. 4. The affected territory comprises 21 parcels located within the City's sphere of influence near Watson Lane and Paoli Loop along with a portion of the Union Pacific Railroad right-of-way. The parcels are identified by the County of Napa Assessor's Office as 057-120-014, 057-120-015, 057-120-017, 057-120-028, 057-120-034, 057-120-036, 057-120-041, 057-120-045, 057-120-047, 057-120-048, 057-120-049, 057-120-050, 057-120-051, 057-180-001, 057-180-002, 057-180-003, 057-180-004, 057-180-005, 057-180-014, 057-180-015, and 059-020-036.

**SPHERE OF INFLUENCE AMENDMENTS AND ANNEXATIONS INVOLVING THE CITY  
OF AMERICAN CANYON, AMERICAN CANYON FIRE PROTECTION DISTRICT, AND  
APNs 057-090-065 & 057-090-066**

Pursuant to California Government Code sections 56425 and 56375, LAFCO will consider sphere of influence amendments and annexations involving the City of American Canyon, the American Canyon Fire Protection District, and two entire unincorporated parcels identified by the County of Napa Assessor's Office as 057-090-065 & 057-090-066. Concurrent detachment of the affected territory from County Service Area No. 4 will also be considered.
